100th Division Maneuver Training Command (MTC)

This about 300 soldier-strong unit was headquartered in the Reserve Center adjacent to the 100th Division HQ on Cannons Lane, Louisville, KY, from about 1973 through 2002. The MTC distinguished itself throughout its existence by conducting outstanding training and evaluations of Army Reserve and National Guard units. Its motto was "The Professionals."

The MTC had 19 teams from the three Army disciplines: Combat, Combat Support and Combat Service Support. Each team consisted of about 10 officers and NCOs who conducted battalion and company level mission, mobility and field training exercises, command post exercises, and readiness tests to Army Reserve and National Guard units throughout the Central United States. The teams were designated and staffed by personnel MOS qualified in Infantry, Armor, Cavalry, Field Artillery, Engineers, Signal, Aviation, Military Intelligence, Transportation, Medical, Maintenance, and Service and Supply.

Teams traveled year-round to Reserve/Guard units Annual Training at various Army posts, their home duty station armories/centers and mobilization stations to conduct evaluations. Soldiers of different MOS were often mixed into Combined Arms evaluation teams to conduct evaluations of unit sections/platoons/companies/battalions and sometimes brigades.

#### **Corridor of the Century**

Nominees must have been truly outstanding in all phases of their Army careers and are no longer assigned to the 100th Division. Contributions by nominees to the excellence of the 100th Division is of primary importance and continued support of the Division is highly desirable. Any former 100th Division Soldier is eligible for nomination. As a minimum, each of the following categories shall be addressed, but nominations are certainly not limited to these areas:

- Years of service in the 100th Division
- Highest Rank Achieved
- Positions held in the 100th Division (and timed served in each, if available)
- Association of the Century Membership, Life or Annual.
- Decorations and awards,
- Extraordinary contributions to the 100th Division. (This category shall be expansive in narrative and specific in nature. This is the most important category in the determination of selectees.)
- Other Community Service
  - 1. Nominations must be typed, single space, to include awards and decorations on one page, and should include an 8"x10" head and shoulders photo.

#### The Scholarship Fund

Before you decide on what to do with your required minimum distribution("RMD") from your individual retirement account, you may want to consider the tax-advantaged strategy of a self-directed charitable donation to The MG Benjamin J. Butler "Century Division" Scholarship Fund (the "Scholarship Fund"). Your donation to the Scholarship Fund may be mailed to Association of the Century, Inc. at P.O. Box 34393, Louisville, KY 40232.

As of the end of calendar year 2023, the Scholarship Fund investment balance is \$289,987 and the funds available for award distributions are currently \$6,828. During 2023, the Scholarship Fund has received \$9,950 in donations.

The Association through the Scholarship Endowment Fund has now granted to the awardees 113 scholarships totaling \$112,000.

#### Changes to the Major General Benjamin J. Butler Scholarship Program

Effective this year, students enrolled in a two-year college are eligible for one award of the scholarship. Other changes include requiring the letters of recommendation be dated in the current year and changing the essay to demonstrate financial need. The criteria is listed below, and the revised application form is included in this newsletter.

<u>Nomination form/applications</u> for scholarship grants may be submitted by qualified individuals who are pursuing a two or four-year degree program at an accredited college or university. There is a lifetime award limit of two awards per applicant. Applicants enrolled in a two-year program may be awarded one scholarship but can apply again once enrolled in a four-year program.

Scholarship grants are made annually from the MG Benjamin J. Butler "Century Division" Scholarship Fund (hereinafter "Fund") which is managed by The Community Foundation of Louisville (hereinafter "Foundation")

Scholarship assistance from the Fund can be used to help defray the full cost or any portion of the cost of any or all of the following: (1) tuition; (2) books; (3) academic fees; (4) room and board expenses for housing made available through the educational institution; and (5) any equipment purchased through the university. Each grant will be at least \$1,000 and will be made payable to the educational institution. All grants will be awarded on an objective and nondiscriminatory basis per the Scholarship Endowment Fund Agreement with The Community Foundation of Louisville.

Eligibility for consideration is based on the following guidelines and will be validated by the AOC initial selection committee:

1. Nominee for the scholarship must be: 1) an active, retired or former member of the United States Army 100th Infantry Division or any of its successor designations, including, but not limited to the 100th Division

(Training) or its successor designations such as 100th Division (Operational Support); or 2) be a direct lineal descendent of one of the foregoing individuals; or 3) be a legally adopted dependent or acknowledged by The Defense Enrollment Eligibility Reporting System (DEERS) as a dependent of one of the foregoing individuals.

2. Nominated individuals must be in the senior year of high school or a high school graduate and must have been accepted for admission to an institution of higher education. Applicants must have a minimum of a 2.5 GPA on a 4.0 scale.

After having met the above requirements, the selection committee established by the Foundation will make the final selection of the winning applicant/applicants based upon (1) demonstrated financial need; (2) qualities of good citizenship and patriotism, as indicated by community service, leadership positions, and/or letters of recommendation; (3) other letters of recommendation; and (4) demonstrated academic excellence.

- 3. The following documentation, as applicable, must be included in the applicant's nominating packet:
- \* American College Test (ACT) Score and/or Scholastic Aptitude Test (SAT) Score
- \* Grade Point Average (GPA) (include High School or current college Transcript)
- \* Membership in National Honor Societies
- \* Honors and Awards Received
- \* Membership in Junior ROTC
- \* Extra Curricular Activities, Community Activities and/or Military Achievement
- \* A typed essay of 250 words on "How This Scholarship Will Help Me Achieve My Goals And Meet My Financial Needs" signed by the applicant.
- \* Two signed letters of recommendation from a non-family member are required to include contact information for the recommending individual. Letters must dated and written during the year of the application.

#### 2023 Financial Highlights

Financial highlights for the 2023 calendar year included the highly successful Annual Meeting, the General's "Franklin Club" Challenge that raised \$3,375 and the continued financial commitment of our *Sentinel* advertisers. The Association of the Century donated \$7,000 to the Scholarship Fund. Annual and life memberships, interest income, and unrestricted donations to the Association increased from the previous years. The AOC will begin the 2024 year with Total Assets (cash & certificates of deposit) of \$131,739 and \$3,400 in inventory of resale inventory, "approximately 238 items (hats, patches, AOC coins, men's shirts, lady's shirts, men's lightweight jackets, T-shirts, fleece vest, hoodies, and a handful of close out old stock shirts)."

**US Congressman Andy Barr Speaks to Lexington Veterans Group** 

National Defense was the topic when US 6th District Congressman Andy Barr spoke to more than 30 veterans at their monthly lunch gathering in Lexington, KY, on March 4, 2024, shown in the photo above.

Congressman Barr warned of increasing People's Republic of China military and economic aggressive actions in both the US and Pacific Region that threaten US and allies' security. He pointed out that the PRC seeks gain military advantage over US allies Taiwan, Philippines, Korea and others by aggressive actions against our Navies, shipping lanes and propaganda. The PRC attempts to evade US trade sanctions in international economic matters by illegally acquiring surveillance and technology to use in its military applications and by accessing US capital markets.

All veterans are invited to attend this monthly meeting held the first Monday of each month at 1100 Hours at Golden Corral Buffet, 184 East New Circle Road, Lexington, KY. Should the first Monday be a legal holiday, the meeting will be held on Tuesday, the day after the holiday.


