#### Association of the Century, Inc. Board of Directors' Meeting First Quarter Treasurer's Report May 8, 2023

- 1. For the first three months ended March 31, 2024, total receipts exceeded total disbursements for a positive increase in cash of \$5,559. Of significance was the receipt of \$3,000 in annual meeting sponsorship from Veterans Of Foreign Wars of The US in Owensboro, Kentucky. The Association also received \$1,200 from Swope Auto Center and \$1,200 from Abound Federal Credit Union for advertisements in the *Century Sentinel*. The 2023 annual website maintenance of \$1,200 was paid for in the first quarter of 2024. As of March 31, 2024, total net assets were \$137,298 consisting of unrestricted assets of \$129,133 and temporarily restricted assets of \$8,165.
- 2. Total investments are \$122,597 at the end of the first quarter. All Certificates of Deposit (CD) are held at Abound Federal Credit Union; presently there are six (6) certificates. On April 29, 2024, certificate of deposit #178614 for \$11,370 was renewed for 10 months at 5.15%. Interest income for the first quarter was \$829.
- 3. During the first quarter, the Museum Fund received no donations and had no expenses. The balance of Temporarily Restricted Assets for the Museum on 31 March 2024 was \$3,357.
- 4. During the first quarter, the Support Our Soldiers (SOS) Program had no expenses or donations. The balance of Temporarily Restricted Assets for the program at the end of the first quarter was \$4,808.
- 5. The SOS Program was started in 2003; as of March 31, 2024 total donations were \$50,042 and expenditures were \$45,234. The balance of Temporarily Restricted Assets for the SOS Program at the end of 2023 was \$4,808.
- 6. The financial activities for the MG Benjamin J. Butler "Century Division" Scholarship Fund for the first quarter of 2024 are outlined in the attached schedule. As of March 31, 2024, the fund balance is \$304,912.35.
- 7. The Scholarship Fund at the Community Foundation of Louisville (CFOL) has always been invested in the Signature Fund Program of the CFOL. As of March 31, "funds available for grantmaking are \$9,036. The Association through the Scholarship Endowment Fund has now granted to the awardees 113 Scholarships totaling 112,000.
- 8. The 2024 operating budget is included with the Statement of Receipts and Disbursements for the three months ended March 31, 2024, in column c. The Board needs to approve this budget.
- 9. Form 990-N for the calendar year ended December 31, 2023 was timely filed with the Internal Revenue Service before May 15, 2024.
- 10. The General's "Franklin Club Challenge" as of May 6, 2024 has raised \$34,957 from 150 participants; \$25,802 has been designated to the Scholarship Fund, \$2,289 to the SOS Fund, \$1,316 to the Museum Fund and \$5,550 has been designated unrestricted. See the attached list of the 150 individuals who have participated in the "Franklin Challenge."
